

JUNIOR PROM 2019

This packet contains all the information needed to attend the Junior Prom. Please read it carefully. You must have your completed packet with you in order to buy your bid. Questions - see Ms. Blair (in B105) before or after school ONLY.

- Prom is April 12th from 6:30 PM to 10:30 PM at The Grand Marquis in Old Bridge, NJ
- Bids are \$85.00 per person. CASH or MONEY ORDER ONLY (made payable to Cash or FTTHS Class of 2020)
- Due to the fact that some students are under the restricted license law, and parking is limited at The Grand Marquis, limos will be permitted at the prom.

For all Juniors attending the Prom, here is the checklist you need to follow. Please check off upon completion.

1. ____ Pay any outstanding fines prior to purchasing your bid. Fine lists will be posted outside B105 and the Main Office. Should you accumulate any other fines prior to the prom, your admittance may be denied.
2. ____ My guest and I have completed **ALL** necessary paperwork:
*Student Contract and Parent/Guardian Contract are filled out and signed.
 - ____ If my guest is **NOT** a Junior, but **DOES GO TO FTTHS**, I had him/her fill out the Guest Contract and the Guest Parent/Guardian Contract.
 - ____ If my guest is **NOT** an FTTHS student, I had him/her fill out the Guest Contract, the Guest Parent/Guardian Contract, and the principal of his/her school has signed his/her paperwork, verifying his/her attendance at that particular school.
3. ____ Buy bid(s) outside the cafeteria in Grand Central: **CASH or MONEY ORDER ONLY!!!**
*Before school from 7:45am - 8:10am, Monday – Friday, March 11-15
*After school Monday, Mar. 11; Tuesday, Mar. 12; Friday, Mar. 15 from 3:15-4:15 pm
There will be **NO after school sales on Wednesday & Thursday, March 13-14**
4. ____ When you purchase the prom bid, pick up a **table form** in order to complete and return to Ms. Blair in B105 no later than **Friday, March 22**. Extra copies will be outside B105. Anyone who does not hand in a table form by March 22th will be placed at a table at the Advisor's discretion. (Note: We will be having a buffet)
5. ____ Plan out transportation for the prom - limos are permitted.

YOU MUST BE present for the entire school day on Thursday 4/11, Friday 4/12 (it is a half day, so the entire student body will be dismissed at 12:54 pm), and Monday 4/15.

Be sure to read over the Junior Prom rules in this packet in regards to attendance and Senior parking privileges.

Rules for FTTHS Junior Prom 2019

1. The Junior Prom is a function sanctioned by the Board of Education. All Board of Education policies relating to drugs and alcohol will be strictly enforced. The use of alcohol, drugs, tobacco and/or any other controlled-dangerous substance before, during or after the prom is prohibited by state law as well as school policy and procedure. Any person under the influence or in possession of an alcoholic beverage or drugs shall be reported to the police for arrest, excluded from the Prom, suspended from school and may be denied participation in future school activities. Parents will be notified. Parents/Guardians are asked to monitor and supervise all pre and post prom activities.
2. Smoking and vaping will not be tolerated inside or on the grounds of the facility. Any violators will be handled with disciplinary action as per board policy.
3. **Students attending the prom must report to school and be marked present the day before the prom (April 11, 2019) and the day of the prom (April 12, 2019) in order to enter the prom. All students (whether attending the prom or not) must report to school and be marked present on the first regularly scheduled day after the prom (April 15, 2019). Seniors absent from school on the first school day following the prom (without a valid doctor's note) jeopardize walking in graduation ceremonies; juniors forfeit senior parking privileges for the following year.**
4. Purchaser of bid and his/her date must be cleared of all fines owed to Freehold Township High School by the time that bids go on sale. If a student accrues a fine after they have purchased a bid, they must clear that fine by the date of the prom, or they will be denied admission.
5. The assistant principal must approve all NON-FTTHS guests. Guests may not be older than 20 years of age and must obey all FRHSD rules and regulations since the prom is a school function. The class advisor, Ms. Blair, **must be notified of any changes in guests.**
6. The purchaser of the bid is responsible for supplying a copy of these rules to his/her guest. **All students and guests must abide by these rules and regulations.**
7. All students and guests are required to submit identification upon request and shall be subject to review by administrators/staff members. Approval for participation shall be at their sole discretion.
8. Proper attire is expected. Students who are not dressed appropriately will be removed from the prom.
9. **No refunds will be given if students are requested to leave the prom for any reason.**
10. All prom-goers will not be permitted to leave the prom until the announcement of the Prince and Princess. Students and guests are not permitted to exit and return to the prom at will. The parking lot and cars will be off limits while the prom is in progress. All bags and personal belongings are subject to search.
11. Prom attendees are under direct supervision of Freehold Township High School during the hours of the prom (6:30 P.M.–10:30 P.M.). Parents/Guardians must assume responsibility from the time of dismissal.
12. Use of alcoholic beverages or any illegal substances is prohibited. Any person under the influence or in possession of an alcoholic beverage or drug shall be reported to the police for arrest, excluded from the prom, and suspended from school. **Seniors will not be permitted to participate in graduation. Underclassmen will not be permitted to attend future proms. BREATH ANALYZERS MAY BE USED by school administration at high school proms.**
13. **There will be NO REFUNDS!**

All bags and personal belongings are subject to search.
